



Enhancements to Columbia Slough Watershed

- \$30,000 per year, 25 years
- Slough Enhancement
- 2014/2015 Project Combined Turtle Habitat Enhancement Project
 - Multi-year project recommended by PDX CAC
 - Multiple project partners
 - Goals: Improve wildlife habitat and water quality through invasive species removal, native plantings, placement of large woody material, monitoring, education and outreach.
 - Total Estimated Cost: \$60,000 (\$54,000)
 - Other Funding: \$7,000

Combined Turtle Habitat Enhancement Project Progress

- Required Permits Fall 2015
 - US Army Corps (Complete)
 - Oregon Department of State Lands
 - City of Portland
- Implementation Summer of 2016
- Columbia Slough Watershed Council Whitaker Ponds turtle enhancement project is complete.
 - Native plants installed in winter 2014/15





Enhancements to Urban Tree Canopy

- Columbia Slough Watershed
- \$20,000 per year, 25 year investment
- 2014/2015/2016 Project Friends of Trees
 - Multi-year Neighborhood Tree Plantings
 - Emphasize Impacted Neighborhoods
 - Emphasize Social Equity as new criteria
 - Continued partnership with Columbia Slough Watershed Council for outreach/volunteer coordination
 - Continued partnership with Verde
- Total Commitment: \$83,673

 - 320 native trees and shrubs




Urban Tree Canopy 2015 Projects

- Airport compatibility (wildlife/Part 77)

 - Multi-year project
 - Unanimous sub-committee recommendation
 - Goals: Protect key riparian trees from beaver predation, contributes to habitat and water quality improvement
 - Columbia Slough Watershed Council Action Plan Project
 - Airport Futures Funding: \$19,618
 - Other Funding: \$10,640
 - Total Project Cost: \$30,258

Enhancements to Columbia Slough Watershed

- \$30,000 per year, 25 years
- Habitat Enhancement
- 2016/2017 Projects Slough Benches
 - Multi-year project
 - Unanimous sub-committee recommendation
 - Goals: Wildlife habitat, water quality, reduced bank erosion and increased storm water retention and filtration
 - Columbia Slough Watershed Council Action Plan Project
 - Airport Futures Funding: \$26,745
 - Other Funding: \$11,040
 - Total Project Cost: \$37,785





Main Channel - Wetland Benches

- Columbia Slough Corps of Engineers 1135 Restoration Project
 - "Dredge material was placed along opposite sides of the channel to create wetland benches and a meandering low water channel. The benches were planted to provide emergent wetland and riparian scrub-shrub wetland vegetation.
 Little emergent marsh habitat is currently available along the main slough, primarily due to the steep banks and narrow channel along most of the project area."
